Second phase of the project Promotion of Sustainable Livelihood around Protected forest area of Kanha Tiger Reserve started by April 2016. The two years project period of first phase was very good learning for organization, team and the community. In this phase we expand our work and reach to more targeted household. During the project lots of learning gained by the project team, the project review / evaluation also conducted and the findings were shared with us to improve the project activities, fill the gap and work with more effectively with technical inputs by technical persons.

There was no major change in project objective and project activities, in this period we continue work with 300 households of 28 villages. As per suggestions of project selection committee of PHF and findings of evaluation, in this first 6 months we focused to work more closely with community, promotion of low cost techniques for composting, SRI on local seed, Strengthen Kisan Panchayat. More technical input from technical / agriculture experts for ginger and turmeric crops. At the start of the project we have listed technical/ agriculture-horticulture experts and invited them to interact with community and staffs during this cultivation period. One experienced agriculture expert has been assigned with project team to work in continues basis. The result of more technical inputs shows this year the ginger and turmeric crops are very good. We have observed the project beneficiaries now in learning the crop cultivation methods for ginger and turmeric. We hope, this year our beneficiary will be able to earn good income by these crops. Similarly, the selected farmers have been started preparation for potato crop. A different kind of satisfaction is there among farmers who have associated with the project before two years.

The team has worked nicely with Kisan Panchayat, The Kisan Panchayat is now taking some good shape, this organization is now in next stage where they are preparing bylaws, rules and regulation and most important taking advocacy steps for common and public issues, i.e. Road, Health and Education services, Payment of MNREGA, filing of petitions' to SDM, DM and forest departments. Working on FRA related issues. We are confident that the local leadership will be emerged soon through Kisan Panchayat, the members of Kisan Panchayat visited collector and SDM office five times during this six month period. Kisan Panchayat is now planning to organize Kisan Panchayat Adhiveshan in the month of Nov. They are contacting various local leaders and Govt. officials for this Adhiveshan.

We have worked seriously on monitoring and documentation of the project, Online and offline reporting system has been placed to collect data and reports. Training to staffs on communication organized to develop their skill for effective community at the field. Project staff is reporting now on tab through collect app. There is two questionnaire for daily reporting, one is beneficiary visit report and second is Daily program report. Both the report has been collected through tab and analyzed monthly and sharing with staff. Two days internal evaluation has been done in the month of July for with all project team at Balaghat. Through this evaluation we categories our beneficiaries and strategy has been finalized to improve our activities, training and technical support. Tab is becoming very useful to project team in terms of their work. We have collected various video of crop cultivation not only ginger and turmeric but other crop / vegetable cultivation. They are using this in their small group meeting and mobilizing community nicely.

2. Training on Vegetable Cultivation

Training on vegetable cultivation organized at the village level, the resource person was invited from horticulture and agriculture department, the whole training was facilitated by project team. The training was exclusively organized for women, last year we train the men members. This year we plan to ensure more involvement of women in ginger and turmeric cultivation. Proper training plan was prepared, used video clipping to ensure more involvement of participants.

3. Training on SRI

Project team discussed at the community, who is interested to do paddy cultivation through SRI methods. Than identified 50 farmers, we invited couple in this training, it was important to invite in couple because there is very important and effective role of women in agriculture. One day training plan and organized in two different batch. 25 households in first batch and 25 in second batch. Before the training paddy plots were identified with the support of family. ADEO of agriculture department was invited for this training. One senior staff of the organization was involved to facilitate the training of SRI. One small booklet was printed and distributed to all participants. Flex also prepared to explain with picture. All the steps were shared nicely with supporting video clips.

4. Training on Low cost Composting

To promote organic farming among project beneficiary we are working seriously on this issue also. Past two years experiences of few farmers was very good. This need to bring in behavior of the community. We are taking this activity in continue process, community have all required material to prepare compost manure, but their long-long experience keeping them in relax. Rural tribal community also now being familiar with chemical fertilizers. Training sessions organizing in part and discussing a lot on all issues i.e. benefits, loss, use, soil fertility, moisture of soil, cost and long term impact. Common practice of the community, they keep cow dung in open and they use before paddy crop. But this kind of cow dung is not useful for crop. Need to promote more to keep cow dung very carefully and need to prepare manure. This is practice issue, which we are tackling. Each and every household should be monitor. During the training we collect action plan of the participant, which will help staff to monitor their progress to prepare pit.

Preparing of Kisan Panchayat bylaws is in progress, they have prepared letter head and stamp to ensure their visibility while advocacy and raising issues. 6. Seed Support

Seed support is an important activity in project, this year we have distributed Turmeric and Ginger to ... beneficiaries. The seeds purchased from different places, Ginger was purchased from Seoni and Balaghat and some quantity purchased from our own project beneficiary of last years. Turmeric was purchased from Durg, Chhattisgarh with the technical support of CCD. This year we tried to purchase seed directly from producer without involving any middlemen.

a. Ginger: as per our previous experience this year staffs discussed a lot and identified more progressive beneficiary who is dedicatedly involve on ginger cultivation. This year we tried to increase net shown area for ginger. We encouraged beneficiaries to increase cultivation area, than only income will increase, 51 famers came forward and show their interest to increase area of cultivation. This is year there was less number of 5 kg or less.

b. **Turmeric**: Similarly we encourage beneficiary to increase area of cultivation, this year we wish to show the benefit to increase production area, everyone interested for turmeric cultivation but they want only 2 to 4 kg. to increase family income it is required to increase area of cultivation. Before seed distribution we organized training for all women of the targeted household and try to involve them.

- c. Potato: There is huge demand of potato, because of this crop taking less time, the family can consume and easily they can market. But we have make strategy for potato seed support also. As per demand estimation for potato is around 50 quintal. We are again encouraging beneficiary to increase area, and promoting farmers to grow white potato also for market in hotel and resorts. The potato seed will be distributed in the month of Oct.
- d. Vegetable: There was demand of other vegetable seeds, organization mobilize vegetable seeds from Horticulture department, Seeds available at our field office, there are seeds of Green leaves(PALAK, BHINDI, KARELA, BEANS, CHILLY, TOMATO) etc. We will be able to support all of our project beneficiaries.

Service of Horticulture experts

As per suggestion of experts in last meeting at PHF New Delhi, this year we identified around 13 agriculture and horticulture experts, discussed individually with them about project and what is our expectations. Than we invited experts to the field, most of the experts directly worked and interact with project beneficiaries. Some have been invited for training and some has been invited for capacity building of project staffs.

Experts spends 34 days with project staff and beneficiaries, they have suggested and discussed on various issues. The result is very good, its like a continue feedback and on site support to project beneficiaries. The ginger and turmeric crops looking good this year. We do hope at least 30 farmers will be able to earn around Rs. 50,000 each.

7. Health - Training /meetings

Health is really most important issue for this area, Only one PHC is situated in Garhi village, and there is no doctor available, this issue has been taken by Kisan Panchayat, Staff has been started attend sector level meeting with AWW and ANM. We have few trained staffs on women and child health and nutrition, so they are taking sessions on health and nutrition for Anganwadi workers, ANM and ASHA. In past 6 months five sector level meetings attended by staffs, With this we are trying to strengthen Health and Sanitation committee of Panchayat. Training for standing committee is planned in the month of Nov.

8. FRA

In past six months staffs worked with targeted villages and collected more information about cases of FRA, Only April to June there was some work and followup of cases with Govt. at Tahsil level. After June 15th there was no work done due to agriculture and rainy season, Only during the Kisan Panchayat meeting this issue has been discussed, Kisan Panchayat is now taking all FRA cases, the members of Kisan Panchayat visited Block and district level for pending application and two gram sabha is trying to prepare application for community rights. As per suggestions through project evaluation document, we have invited one resource person from Nari-Utthan to facilitate the process.



- b. **Staff training on Communication**: Two days training for staffs organized at Balaghat, the training was facilitated by Mr. Ameen Charles and Mr. Wilson Lobo, Staff demands to organize more training in regular interval.
- c. Internal Evaluation of the Project: In the month of July, we have done internal evaluation process with staff at Balaghat, In this two days process we try to find gap on project and discussed on different strategies to ensure effective implementation of the project. Through an exercise all the families has been categories in A, B and C and collective develop strategy for each category. It is also decided to organize this type of exercise in every three to four months.
- d. Monitoring, Reporting and Documentation: This year we trying to collect more qualitative reports and effective monitoring and support to staffs, Collect app is now available to all field staffs, and there is two questionnaire for daily reporting. One is daily report form and second is beneficiary visit reports. Project head and Executive Director is making weekly analysis of these reports and regular feedback to staffs. Along with these there is two monthly reports from staff through google sheets. We are trying to collect most of reports online, during the monthly staff meeting we promote and skill our staff to use computer and other technology.
